- 1 Amend reengrossed bill, page 3, line 24, after "(1)(a)," insert "(2)(d),".
- 2 Page 4, after line 3 insert:
- 3 "(2) (d) The firearm dealer permit cash fund is created in the state
4 treasury. The fund consists of money credited to the fund pursuant to
5 subsection (2)(c) of this section and any other money that the general
6 assembly may appropriate or transfer to the fund. The state treasurer shall
7 credit all interest and income derived from the deposit and investment of
8 money in the firearm dealer permit cash fund to the fund. Money in the
9 fund is continuously appropriated to the department for the costs of
10 issuing permits and conducting inspections pursuant to this section AND
11 AWARDED ASSISTANCE GRANTS PURSUANT TO SECTION 18-12-406
12 (2.5)(b)(II).".
- 13 Page 9, line 14, strike "(2.5)(b)" and substitute "(2.5)(c)".
- 14 Page 9, after line 20 insert:
- 15 "(b) (I) BEFORE ENFORCING A NEW SECURITY MEASURE REQUIRED
16 IN THE DEPARTMENT'S RULES, THE DEPARTMENT MUST PREPARE AND
17 PUBLISH ON A PUBLICLY AVAILABLE PAGE OF ITS WEBSITE A SMALL
18 BUSINESS IMPACT ANALYSIS OF IMPLEMENTING THE NEW SECURITY
19 MEASURE THAT ESTIMATES THE COST OF COMPLIANCE.
- 20 (II) IF, IN ACCORDANCE WITH THE SMALL BUSINESS IMPACT
21 ANALYSIS, THE DEPARTMENT DETERMINES THAT COMPLIANCE COSTS FOR
22 A SPECIFIC REQUIRED SECURITY MEASURE EXCEED FIVE PERCENT OF
23 PRIOR-YEAR GROSS REVENUE OF A STATE PERMIT HOLDER WHO OPERATES
24 A SMALL BUSINESS, THE DEPARTMENT SHALL ALLOW THE STATE PERMIT
25 HOLDER A PHASED COMPLIANCE PERIOD OF NOT LESS THAN TWENTY-FOUR
26 MONTHS FOR THE REQUIRED SECURITY MEASURE OR AWARD THE STATE
27 PERMIT HOLDER AN ASSISTANCE GRANT FROM THE FIREARM DEALER
28 PERMIT CASH FUND CREATED IN SECTION 18-12-401.5 (2)(d) TO SUPPORT
29 IMPLEMENTATION OF THE REQUIRED SECURITY MEASURE. THE
30 DEPARTMENT SHALL ADOPT POLICIES FOR STATE PERMIT HOLDERS TO
31 APPLY FOR ASSISTANCE GRANTS AND FOR THE DEPARTMENT TO REVIEW
32 APPLICATIONS AND AWARD GRANTS. THE POLICIES MUST INCLUDE
33 CRITERIA FOR DETERMINING WHETHER AN APPLICANT OPERATES A SMALL
34 BUSINESS.".
- 35 Page 9, line 21, strike "(b)" and substitute "(c)".
