20 To establish, on an emergency basis, fines for criminal offenses, except where exempted by
21 specific reference, proportional to the imprisonment term for each offense and to add a
22 fine to any criminal offense that is currently punishable by a term of imprisonment but
23 not by a fine; to establish the maximum alternative fine penalty involving pecuniary gain
24 or loss at twice the gain or loss that has been alleged and proved; to exempt certain
25 offenses from the fine proportionality in order to retain large fines for those offenses, to
26 exempt certain offenses from fine proportionality in order to retain the progressive fine
27 structure for subsequent offenses; to make conforming amendments to acts codified in
28 Titles 22, 48, 50, and enacted titles of the District of Columbia Official Code; to clarify
29 that the provisions of this act cannot be applied retroactively; and to provide a definitive
30 effective date for the act of June 1, 2013.

32 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
33 act may be cited as the "Criminal Fine Proportionality Emergency Amendment Act of 2013".
34

35 TITLE I -- CRIMINAL FINE PROPORTIONALITY
36 SUBTITLE A. FINES FOR CRIMINAL OFFENSES

37 Sec. 101. Fines for criminal offenses.

38 (a) Notwithstanding any other provision of the law, and except as provided in section
39 102, a defendant who has been found guilty of an offense under the District of Columbia Official
40 Code punishable by imprisonment may be sentenced to pay a fine as provided in this section.

41 (b) An individual who has been found guilty of such an offense may be fined not more
42 than the greatest of:

- 43 (1) \$100 if the offense is punishable by imprisonment for 10 days or less;
44 (2) \$250 if the offense is punishable by imprisonment for 30 days, or one month,
45 or less but more than 10 days;

1 (3) \$500 if the offense is punishable by imprisonment for 90 days, or 3 months,
2 or less but more than 30 days;

3 (4) \$1,000 if the offense is punishable by imprisonment for 180 days, or 6
4 months, or less but more than 90 days;

5 (5) \$2,500 if the offense is punishable by imprisonment for one year or less but
6 more than 180 days;

7 (6) \$12,500 if the offense is punishable by imprisonment for 5 years or less but
8 more than one year;

9 (7) \$25,000 if the offense is punishable by imprisonment for 10 years or less but
10 more than 5 years;

11 (8) \$37,500 if the offense is punishable by imprisonment for 15 years or less but
12 more than 10 years;

13 (9) \$50,000 if the offense is punishable by imprisonment for 20 years or less but
14 more than 15 years;

15 (10) \$75,000 if the offense is punishable by imprisonment for 30 years or less but
16 more than 20 years;

17 (11) \$125,000 if the offense is punishable by imprisonment for more than 30
18 years; or

19 (12) \$250,000 if the offense resulted in death.

20 (c) An organization that has been found guilty of an offense punishable by imprisonment
21 for 6 months or more may be fined not more than the greatest of:

22 (1) Twice the maximum amount specified in the law setting forth the penalty for
23 the offense;

24 (2) Twice the applicable amount under subsection (b) of this section; or

25 (3) Twice the applicable amount under section 102(a).

27 **Sec. 102. Applicability of fine proportionality provision.**

28 (a) Notwithstanding any other provision of law, a sentence to pay a fine under section
29 101 shall be subject to the following:

30 (1) If a law setting forth the penalty for such an offense specifies a maximum fine that is
31 lower than the fine otherwise applicable under section 101 and such law, by specific reference,
32 exempts the offense from the applicability of the fine otherwise applicable under section 101, the
33 defendant may not be fined more than the maximum amount specified in the law setting forth the
34 penalty for the offense.

35 (2) If a law setting forth the penalty for such an offense specifies a maximum fine
36 that is higher than the fine otherwise applicable under section 101 and such law, by specific
37 reference, exempts the offense from the applicability of the fine otherwise applicable under
38 section 101, the defendant may be fined the maximum amount specified in the law setting forth
39 the penalty for the offense.

40 (3) If a law setting forth the penalty for such an offense specifies no fine and such
41 law, by specific reference, does not exempt the offense from the fine otherwise applicable under
42 section 101, the defendant may be fined pursuant to section 101.

43 (b)(1) If any person derives pecuniary gain from such an offense, or if the offense results
44 in pecuniary loss to a person other than the defendant, the defendant may be fined not more than
45 the greater of twice the gross gain or twice the gross loss.

1 (2) The court may impose a fine under this subsection in excess of the fine
2 provided for by section 101 only to the extent that the pecuniary gain or loss is both alleged in
3 the indictment or information and is proven beyond a reasonable doubt.

4 (c) This act shall not apply to any provision of Title 11 of the District of Columbia
5 Official Code.

7 SUBTITLE B. EXEMPTIONS TO CRIMINAL FINE PROPORTIONALITY

8 Sec. 111. Modification to alternative maximum fine based on gain or loss.

32 "The fine set forth in this section shall not be limited by section 101 of the Criminal Fine
