

SENATE BILL No. 331

DIGEST OF INTRODUCED BILL

Citations Affected: IC 29-3-5-3; IC 33-23-15-1; IC 35-47-1-7.

Synopsis: Adult permanent guardianship cases. Provides that, in a proceeding on a petition for adult permanent guardianship, if the court finds that the appointment of a guardian is necessary, the court shall transmit to the division of state court administration certain information for transmission to the National Instant Criminal Background Check System maintained by the Federal Bureau of Investigation in accordance with the federal Brady Handgun Violence Prevention Act. Makes corresponding amendments.

Effective: July 1, 2016.

A BILL FOR AN ACT to amend the Indiana Code concerning probate.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 29-3-5-3 IS AMENDED TO READ AS FOLLOWS
2 [EFFECTIVE JULY 1, 2016]: Sec. 3. (a) Except under subsection (c),
3 if it is alleged and the court finds that:
4 (1) the individual for whom the guardian is sought is an
5 incapacitated person or a minor; and
6 (2) the appointment of a guardian is necessary as a means of
7 providing care and supervision of the physical person or property
8 of the incapacitated person or minor;
9 the court shall appoint a guardian under this chapter.
10 (b) If it is alleged and the court finds that the welfare of an
11 incapacitated person would be best served by limiting the scope of the
12 guardianship, the court shall make the appointive or other orders under
13 this chapter to:
14 (1) encourage development of the incapacitated person's
15 self-improvement, self-reliance, and independence; and
16 (2) contribute to the incapacitated person's living as normal a life
17 as that person's condition and circumstances permit without



1 psychological or physical harm to the incapacitated person.

2 (c) If the court finds that it is not in the best interests of the
3 incapacitated person or minor to appoint a guardian, the court may:

- 4 (1) treat the petition as one for a protective order and proceed
5 accordingly;
6 (2) enter any other appropriate order; or
7 (3) dismiss the proceedings.

8 **(d) If the court makes a finding under subsection (a) on a**
9 **petition for adult permanent guardianship, the court shall transmit**
10 **any information required by the division of state court**
11 **administration to the division of state court administration for**
12 **transmission to the NICS (as defined in IC 35-47-2.5-2.5) in**
13 **accordance with IC 33-24-6-3.**

14 SECTION 2. IC 33-23-15-1, AS ADDED BY P.L.110-2009,
15 SECTION 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
16 JULY 1, 2016]: Sec. 1. This chapter applies to the following:

- 17 (1) A person civilly committed under IC 12-26-6-8.
18 (2) A person found to be mentally ill and either dangerous or
19 gravely disabled under IC 12-26-7-5.
20 (3) A person found guilty but mentally ill under IC 35-36-2-5.
21 (4) A person found not responsible by reason of insanity under
22 IC 35-36-2-4.
23 (5) A person found incompetent to stand trial under IC 35-36-3-1.
24 (6) A confined offender who is determined to be mentally ill and
25 has been involuntarily transferred to and accepted by the division
26 of mental health and addiction under IC 11-10-4-3.
27 **(7) A person subject to an adult permanent guardianship**
28 **under IC 29-3-5-3.**

29 SECTION 3. IC 35-47-1-7, AS AMENDED BY P.L.126-2012,
30 SECTION 57, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
31 JULY 1, 2016]: Sec. 7. "Proper person" means a person who:

- 32 (1) does not have a conviction for resisting law enforcement
33 under IC 35-44.1-3-1 within five (5) years before the person
34 applies for a license or permit under this chapter;
35 (2) does not have a conviction for a crime for which the person
36 could have been sentenced for more than one (1) year;
37 (3) does not have a conviction for a crime of domestic violence
38 (as defined in IC 35-31.5-2-78), unless a court has restored the
39 person's right to possess a firearm under IC 35-47-4-7;
40 (4) is not prohibited by a court order from possessing a handgun;
41 (5) does not have a record of being an alcohol or drug abuser as
42 defined in this chapter;



- 1 (6) does not have documented evidence which would give rise to
 2 a reasonable belief that the person has a propensity for violent or
 3 emotionally unstable conduct;
 4 (7) does not make a false statement of material fact on the
 5 person's application;
 6 (8) does not have a conviction for any crime involving an inability
 7 to safely handle a handgun;
 8 (9) does not have a conviction for violation of the provisions of
 9 this article within five (5) years of the person's application;
 10 (10) does not have an adjudication as a delinquent child for an act
 11 that would be a felony if committed by an adult, if the person
 12 applying for a license or permit under this chapter is less than
 13 twenty-three (23) years of age;
 14 (11) has not been involuntarily committed, other than a temporary
 15 commitment for observation or evaluation, to a mental institution
 16 by a court, board, commission, or other lawful authority;
 17 (12) has not been the subject of a:
 18 (A) ninety (90) day commitment as a result of proceeding
 19 under IC 12-26-6; or
 20 (B) regular commitment under IC 12-26-7; **or**
 21 (13) has not been found by a court to be mentally incompetent,
 22 including being found:
 23 (A) not guilty by reason of insanity;
 24 (B) guilty but mentally ill; or
 25 (C) incompetent to stand trial; **or**
 26 **(14) has not been found under IC 29-3-5-3 to be an**
 27 **incapacitated person or minor for whom the appointment of**
 28 **a guardian was necessary as a means of providing care and**
 29 **supervision of the person's physical person or property.**
