A BILL ENTITLED

1 AN ACT concerning

2 **Firearms – Handgun Qualification License – Live–Fire Component**

3 FOR the purpose of providing that the firearms orientation component of a certain firearms
4 safety training course required to be taken by a person to be issued a certain
5 handgun qualification license need not include a practice component requiring the
6 person to fire rounds of live ammunition; and generally relating to firearms.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

13 That the Laws of Maryland read as follows:

14 **Article – Public Safety**

15 5–117.1.

16 (d) Subject to subsections (f) and (g) of this section, the Secretary shall issue a
17 handgun qualification license to a person who the Secretary finds:

18 (1) is at least 21 years old;

19 (2) is a resident of the State;

1 (3) except as provided in subsection (e) of this section, has demonstrated
2 satisfactory completion, within 3 years prior to the submission of the application, of a
3 firearms safety training course approved by the Secretary that includes:

4 (i) a minimum of 4 hours of instruction by a qualified handgun
5 instructor;

6 (ii) classroom instruction on:

7 1. State firearm law;

8 2. home firearm safety; and

9 3. handgun mechanisms and operation; and

10 (iii) a firearms orientation component that:

11 1. demonstrates the person's safe operation and handling of
12 a firearm; **BUT**

13 2. **NEED NOT INCLUDE A PRACTICE COMPONENT**
14 **REQUIRING THE PERSON TO FIRE ROUNDS OF LIVE AMMUNITION;** and

15 (4) based on an investigation, is not prohibited by federal or State law from
16 purchasing or possessing a handgun.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2016.
