1 AN ACT concerning

2 **Children – Child Care Facilities, Public Schools, and Nonpublic Schools –**
3 **Contractors and Subcontractors**

4 FOR the purpose of prohibiting certain county boards of education and certain nonpublic
5 schools from ~~allowing certain individuals to hire or retain~~ hiring or retaining certain
6 individuals who have been convicted of certain crimes; requiring certain contracts to
7 provide that certain contractors or subcontractors for certain nonpublic schools and
8 certain local school systems may not knowingly assign employees to work on school
9 premises with certain access to children if the employee has been convicted of certain
10 crimes; authorizing the State Board of Education to revoke a certain certificate of
11 approval or letter of tentative approval of a nonpublic school under certain
12 circumstances; adding certain contractors and subcontractors who have certain
13 access to certain children to the list of individuals required to obtain a certain
14 criminal history records check; ~~amending a certain definition of “employee” to~~

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

Article – Education

2–206.1.

(a) A nonpublic school that is subject to the requirements of this title may not hire or retain ~~any employee~~ ~~AN INDIVIDUAL OR ALLOW A CONTRACTOR OR SUBCONTRACTOR FOR THE NONPUBLIC SCHOOL TO HIRE OR RETAIN AN INDIVIDUAL~~ who works with or has access to students and who the school knows has been convicted of a crime involving:

(1) An offense under § 3–307 OR § 3–308 of the Criminal Law Article OR AN OFFENSE UNDER THE LAWS OF ANOTHER STATE THAT WOULD CONSTITUTE A

1 **VIOLATION OF § 3-307 OR § 3-308 OF THE CRIMINAL LAW ARTICLE IF COMMITTED**
 2 **IN THE STATE;**

3 (2) Child sexual abuse under § 3-602 of the Criminal Law Article, or an
 4 offense under the laws of another state that would constitute child sexual abuse under §
 5 3-602 of the Criminal Law Article if committed in this State; or

6 (3) A crime of violence as defined in § 14-101 of the Criminal Law Article,
 7 or an offense under the laws of another state that would be a violation of § 14-101 of the
 8 Criminal Law Article if committed in this State.

9 **(B) A NONPUBLIC SCHOOL CONTRACT SHALL PROVIDE THAT A**
 10 **CONTRACTOR OR SUBCONTRACTOR FOR THE SCHOOL MAY NOT KNOWINGLY ASSIGN**
 11 **AN EMPLOYEE TO WORK ON SCHOOL PREMISES WITH DIRECT, UNSUPERVISED, AND**
 12 **UNCONTROLLED ACCESS TO CHILDREN, IF THE EMPLOYEE HAS BEEN CONVICTED OF**
 13 **A CRIME IDENTIFIED UNDER SUBSECTION (A) OF THIS SECTION.**

 3 KNOWINGLY ASSIGN AN EMPLOYEE TO WORK ON SCHOOL PREMISES WITH DIRECT,
 4 UNSUPERVISED, AND UNCONTROLLED ACCESS TO CHILDREN, IF THE EMPLOYEE HAS
 5 BEEN CONVICTED OF A CRIME IDENTIFIED UNDER SUBSECTION (A) OF THIS
 6 SECTION.

11 (d) (1) “Employee” means a person that for compensation is employed to work
 12 in a facility identified in § 5–561 of this subtitle and who:

13 (i) cares for or supervises children in the facility; or

14 (ii) has access to children who are cared for or supervised in the
 15 facility.

16 (2) “Employee” includes a person who:

17 (i) participates in a pool described in subsection (e)(2) of this section;

18 (ii) for compensation will be employed on a substitute or temporary
 19 basis to work in a facility identified in § 5–561(b)(1) or (2) of this subtitle; and

20 (iii) will care for or supervise children in the facility or will have
 21 access to children who are cared for or supervised in the facility.

2 check at any designated law enforcement office in this State or other location approved by
3 the Department.

4 (b) The following facilities shall require employees and employers to obtain a
5 criminal history records check under this Part VI of this subtitle:

6 (1) a child care center required to be licensed under Part VII of this
7 subtitle;

8 (2) a family child care home or large family child care home required to be
9 registered under Part V of this subtitle;

10 (3) a child care home required to be licensed under this subtitle or under
11 Title 9 of the Human Services Article;

12 (4) a child care institution required to be licensed under this subtitle or
13 under Title 9 of the Human Services Article;

14 (5) a juvenile detention, correction, or treatment facility provided for in
15 Title 9 of the Human Services Article;

16 (6) a public school as defined in Title 1 of the Education Article;

17 (7) a private or nonpublic school required to report annually to the State
18 Board of Education under Title 2 of the Education Article;

19 (8) a foster care family home or group facility as defined under this subtitle;

20 (9) a recreation center or recreation program operated by the State, a local
21 government, or a private entity primarily serving minors;

22 (10) a day or residential camp, as defined in Title 10, Subtitle 16 of the Code
23 of Maryland Regulations, primarily serving minors; or

24 (11) a home health agency or residential service agency licensed by the
25 Department of Health and Mental Hygiene and authorized under Title 19 of the Health –
26 General Article to provide home– or community–based health services for minors.

27 **(B-1) A CONTRACTOR OR SUBCONTRACTOR SHALL REQUIRE AN**
28 **EMPLOYEE THAT WILL HAVE DIRECT, UNSUPERVISED, AND UNCONTROLLED ACCESS**
29 **TO CHILDREN IN A FACILITY LISTED IN SUBSECTION (B) OF THIS SECTION TO OBTAIN**
30 **A CRIMINAL HISTORY RECORDS CHECK UNDER THIS PART VI OF THIS SUBTITLE.**

32 1, 2015.
