1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2020, section 609.2325, is amended to read:

1.10 **609.2325 CRIMINAL ABUSE.**

1.11 Subdivision 1. **Crimes.** ~~(a)~~ A caregiver who, with intent to produce physical or mental
1.12 pain or injury to a vulnerable adult, subjects a vulnerable adult to any aversive or deprivation
1.13 procedure, unreasonable confinement, or involuntary seclusion, is guilty of criminal abuse
1.14 and may be sentenced as provided in subdivision 3.

1.15 This ~~paragraph~~ subdivision does not apply to therapeutic conduct.

1.16 ~~(b) A caregiver, facility staff person, or person providing services in a facility who~~
1.17 ~~engages in sexual contact or penetration, as defined in section 609.341, under circumstances~~
1.18 ~~other than those described in sections 609.342 to 609.345, with a resident, patient, or client~~
1.19 ~~of the facility is guilty of criminal abuse and may be sentenced as provided in subdivision~~

1.21 Subd. 2. **Exemptions.** For the purposes of this section, a vulnerable adult is not abused
1.22 for the sole reason that:

2.1 (1) the vulnerable adult or a person with authority to make health care decisions for the
2.2 vulnerable adult under sections 144.651, 144A.44, chapter 145B, 145C, or 252A, or sections
2.3 253B.03 or 524.5-101 to 524.5-502, refuses consent or withdraws consent, consistent with
2.4 that authority and within the boundary of reasonable medical practice, to any therapeutic
2.5 conduct, including any care, service, or procedure to diagnose, maintain, or treat the physical
2.6 or mental condition of the vulnerable adult or, where permitted under law, to provide nutrition
2.7 and hydration parenterally or through intubation; this paragraph does not enlarge or diminish
2.8 rights otherwise held under law by:

2.9 (i) a vulnerable adult or a person acting on behalf of a vulnerable adult, including an
2.10 involved family member, to consent to or refuse consent for therapeutic conduct; or

2.11 (ii) a caregiver to offer or provide or refuse to offer or provide therapeutic conduct; or

2.12 (2) the vulnerable adult, a person with authority to make health care decisions for the
2.13 vulnerable adult, or a caregiver in good faith selects and depends upon spiritual means or

2.26 15 years or payment of a fine of not more than \$30,000, or both;

23.3 Subd. 2. **Mandatory life sentence without release; egregious first-time and repeat**

28.24 shall convene a working group to comprehensively assess the predatory offender statutory
28.25 framework. The commissioner shall invite representatives from city and county prosecuting
28.26 agencies, statewide crime victim coalitions, the Minnesota judicial branch, the Minnesota
28.27 Board of Public Defense, private criminal defense attorneys, the Department of Public
28.28 Safety, the Department of Human Services, the Sentencing Guidelines Commission, state
28.29 and local law enforcement agencies, and other interested parties to participate in the working
28.30 group. The commissioner shall ensure that the membership of the working group is balanced

29.5 Governmental agencies that hold POR data shall provide the working group with public
29.6 POR data upon request. The working group is encouraged to request the assistance of the
29.7 state court administrator's office to obtain relevant POR data maintained by the court system.

29.8 Subd. 3. **Report to legislature.** The commissioner shall file a report detailing the working
29.9 group's findings and recommendations with the chairs and ranking minority members of
29.10 the house of representatives and senate committees and divisions having jurisdiction over
29.11 public safety and judiciary policy and finance by January 15, 2022.

29.12 **Sec. 18. REVISOR INSTRUCTION.**

29.13 The revisor of statutes shall make necessary cross-reference changes and remove statutory
29.14 cross-references in Minnesota Statutes to conform with this act. The revisor may make
29.15 technical and other necessary changes to language and sentence structure to preserve the
29.16 meaning of the text.

29.17 **Sec. 19. REPEALER.**

29.18 Minnesota Statutes 2020, sections 609.293, subdivisions 1 and 5; 609.34; and 609.36,
29.19 are repealed.

609.293 SODOMY.

Subdivision 1. **Definition.** "Sodomy" means carnally knowing any person by the anus or by or with the mouth.

Subd. 5. **Consensual acts.** Whoever, in cases not coming within the provisions of sections 609.342 or 609.344, voluntarily engages in or submits to an act of sodomy with another may be sentenced to imprisonment for not more than one year or to payment of a fine of not more than \$3,000, or both.

609.34 FORNICATION.

When any man and single woman have sexual intercourse with each other, each is guilty of fornication, which is a misdemeanor.

609.36 ADULTERY.

Subdivision 1. **Acts constituting.** When a married woman has sexual intercourse with a man other than her husband, whether married or not, both are guilty of adultery and may be sentenced to imprisonment for not more than one year or to payment of a fine of not more than \$3,000, or both.

Subd. 2. **Limitations.** No prosecution shall be commenced under this section except on complaint of the husband or the wife, except when such husband or wife lacks the mental capacity, nor after one year from the commission of the offense.

Subd. 3. **Defense.** It is a defense to violation of this section if the marital status of the woman was not known to the defendant at the time of the act of adultery.
