8 AS INTRODUCED

9 A Resolution congratulating and honoring Alexandria
10 (Lexie) Lerblance as a recipient of a Prudential
11 Spirit of Community Award; and directing
12 distribution.

14 WHEREAS, Alexandria (Lexie) Lerblance, an esteemed resident of
15 McAlester, Oklahoma, and a student at McAlester High School, has
16 achieved national recognition for exemplary volunteer service by
17 receiving a 2015 Prudential Spirit of Community Award; and

18 WHEREAS, this prestigious award, presented by Prudential
19 Financial in partnership with the National Association of Secondary
20 School Principals, honors young volunteers across America who have
21 demonstrated an extraordinary commitment to serving their
22 communities; and

23 WHEREAS, Ms. Lerblance earned this award by giving generously of
24 her time and energy by cofounding a nonprofit organization that has

1 donated nearly \$20,000 worth of wigs and other head coverings over
2 the past four years to approximately 150 cancer patients in an
3 eight-county region; and

4 WHEREAS, Ms. Lerblance and her mother began their work by
5 persuading a local hospital to let them use a room for their closet,
6 partnering with a local beauty school to clean and style donated
7 wigs, and asking the American Cancer Society to help raise money and
8 get the word out to patients; and

9 WHEREAS, Ms. Lerblance's main role has been to raise funds and
10 solicit donations of wigs, scarves, hats and turbans, in large part
11 by speaking to civic organizations using a PowerPoint presentation;
12 and

13 WHEREAS, as a recipient of a Prudential Spirit of Community
14 Award, she will receive \$1,000, an engraved silver medallion and an
15 all-expense-paid trip in early May to Washington, D.C., where she
16 will join the top two honorees from each state and the District of
17 Columbia for four days of national recognition events; and

18 WHEREAS, the success of the State of Oklahoma, the strength of
19 our communities, and the overall vitality of American society depend
20 in great measure upon the dedication of young people like Ms.
21 Lerblance who use their considerable talents and resources to serve
22 others.

23 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
24 OF THE 1ST SESSION OF THE 55TH OKLAHOMA LEGISLATURE:

1 THAT the Oklahoma House of Representatives hereby congratulates
2 and honors Alexandria (Lexie) Lerblance as a recipient of a
