SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[For purposes of personal income taxation, changes connection point from federal taxable income to federal adjusted gross income by eliminating allowance of itemized deductions or standard deduction. Modifies rates of personal income taxation.]

[Applies to tax years beginning on or after January 1, 2016.]

Extends sunsets for certain income and excise tax credits.

Directs Legislative Revenue Officer to prepare analysis of options for restructuring state and local revenue system and to submit report on progress of analysis to interim committees of Legislative Assembly.

Creates refundable tax credit for employment-related household services and dependent care expenses. Applies to tax years beginning on or after January 1, 2016, and before January 1, 2022. Modifies credit for individual development account contribution by expanding eligible uses of funds and removing limitation on taxpayer contributions. Restricts availability of additional personal exemption credits for taxpayer with severe disability or with disabled child, based on taxpayer income. Modifies tax credit for rural medical provider based on distance from major population center. Reduces percentage available for credit for contributions to Office of Child Care.

For purpose of residential energy tax credit, modifies conditions for credit allowed for certain category one alternative energy devices that use solar radiation. Modifies credit limits for each type of category one alternative energy device. Authorizes State Department of Energy to adopt rules that further limit amount of credit based upon market conditions. Removes obsolete provisions related to tax credits previously allowed for alternative fuel vehicles and related equipment and fueling stations. First applies to alternative energy devices certified on or after September 1, 2015, and tax years beginning on or after January 1, 2015.

Shortens sunset for tax credit for long term care insurance premiums.

Provides that corporate minimum tax may not be reduced, paid or otherwise satisfied by use of tax credits. Applies to tax years beginning on or after January 1, 2015, and before January 1, 2021.

Modifies definition of "resident" for purposes of personal income taxation to exclude certain members of Armed Forces if residency as reflected in payroll records is located outside state. Requires taxpayers to file amended returns to claim refunds of exempted amounts for prior tax years. Applies to tax years beginning on or after January 1, 2012.

Takes effect on 91st day following adjournment sine die.

1 **Be It Enacted by the People of the State of Oregon:**

2 **SECTION 1. (1) The Legislative Revenue Officer, in consultation with the Department of**
 3 **Revenue and other relevant state agencies, shall prepare an analysis of options for restruc-**
 4 **turing Oregon’s state and local revenue system.**

5 **(2) Options to be analyzed pursuant to this section shall include:**

6 **(a) Alternatives for restructuring the property tax system.**

7 **(b) Alternative methods of taxing consumption in the state.**

8 **(c) Alternative methods for taxing business in the state including taxes based on net in-**
 9 **come, and commercial activity and value added taxes.**

10 **(d) Alternatives for restructuring the personal income tax.**

11 **(3) Analysis for each option, or combination of options, examined pursuant to this section**
 12 **shall include the estimated impact on:**

13 **(a) Oregon’s economy.**

14 **(b) State and local tax revenue.**

15 **(c) Distribution of the state and local tax burden.**

16 **(d) Stability of the state and local revenue system.**

17 **(4) Not later than December 1, 2015, the Legislative Revenue Officer shall submit a report**
 18 **to the interim committees of the Legislative Assembly related to revenue on the progress**
 19 **of the analysis required under this section.**

20 **SECTION 2. Section 3 of this 2015 Act is added to and made a part of ORS chapter 315.**

21 **SECTION 3. (1)(a) A credit against the tax otherwise due under ORS chapter 316 shall**
 22 **be allowed a taxpayer in an amount equal to a percentage of employment-related expenses**
 23 **of a type allowable as a credit pursuant to section 21 of the Internal Revenue Code,**
 24 **notwithstanding the limitation imposed by section 21(c) of the Internal Revenue Code, and**
 25 **limited as provided in paragraph (b) of this subsection.**

26 **(b) The employment-related expenses for which a credit is claimed under this section**
 27 **may not exceed \$12,000 for a taxpayer for which there is one qualifying individual, or \$24,000**
 28 **for a taxpayer for which there are two or more qualifying individuals.**

29 **(2) The applicable percentage described in subsection (1) of this section shall be deter-**

28 **(3) The applicable percentage for a household in excess of eight members shall be calcu-**
 29 **lated as if for a household size of eight members.**

30 **(4) The credit under this section is not allowed to a taxpayer with federal adjusted gross**
 31 **income or Oregon adjusted gross income, whichever is greater, in excess of 300 percent of**
 32 **the federal poverty level.**

33 **(5) In order to ensure compliance with the eligibility requirements of the credit allowed**
 34 **under this section, the Department of Revenue shall be afforded access to utilization data**
 35 **maintained by the Department of Human Services in its administration of the Employment**
 36 **Related Day Care program.**

37 **(6) The Director of the Department of Revenue may assess a penalty in an amount not**
 38 **to exceed 25 percent of the amount of credit claimed by the taxpayer against any taxpayer**
 39 **who knowingly claims or attempts to claim any amount of credit under this section for which**
 40 **the taxpayer is ineligible, or against any individual who knowingly assists another individual**

45 **(8) A nonresident individual shall be allowed the credit computed in the same manner and**

1 subject to the same limitations as the credit allowed a resident by subsection (1) of this
2 section. However, the credit shall be prorated using the proportion provided in ORS 316.117.

3 (9) If a change in the taxable year of a taxpayer occurs as described in ORS 314.085, or
4 if the Department of Revenue terminates the taxpayer's taxable year under ORS 314.440, the
5 credit allowed by this section shall be prorated or computed in a manner consistent with ORS
6 314.085.

7 (10) If a change in the status of a taxpayer from resident to nonresident or from non-
8 resident to resident occurs, the credit allowed by this section shall be determined in a man-
9 ner consistent with ORS 316.117.

10 (11) If the amount allowable as a credit under this section, when added to the sum of the
11 amounts allowable as payment of tax under ORS 316.187 or 316.583, other tax prepayment
12 amounts and other refundable credit amounts, exceeds the taxes imposed by ORS chapters
13 314 and 316 for the tax year after application of any nonrefundable credits allowable for
14 purposes of ORS chapter 316 for the tax year, the amount of the excess shall be refunded to
15 the taxpayer as provided in ORS 316.502.

38 to 348.873 on behalf of a designated beneficiary, the establishment of an additional college savings
39 network account on behalf of the same designated beneficiary.

40 (d) The purchase of a primary residence. In addition to payment on the purchase price of the
41 residence, account moneys may be used to pay any usual or reasonable settlement, financing or
42 other closing costs. The account holder must not have owned or held any interest in a residence
43 during the three years prior to making the purchase. However, this three-year period shall not apply
44 to displaced homemakers, [or other] individuals who have lost home ownership as a result of divorce
45 **or owners of manufactured homes.**

1 **(e) The rental of a primary residence when housing stability is essential to achieve state**
2 **policy goals. Account moneys may be used for security deposits, first and last months' rent,**
3 **application fees and other expenses necessary to move into the primary residence, as speci-**
4 **fied in the account holder's personal development plan for increasing the independence of the**
5 **person.**

6 [(e)] **(f) The capitalization of a small business. Account moneys may be used for capital, plant,**
7 **equipment and inventory expenses and to hire employees upon capitalization of the small busi-**
8 **ness, or for working capital pursuant to a business plan. The business plan must have been devel-**
9 **oped by a financial institution, nonprofit microenterprise program or other qualified agent**
10 **demonstrating business expertise and have been approved by the fiduciary organization. The busi-**
11 **ness plan must include a description of the services or goods to be sold, a marketing plan and**
12 **projected financial statements.**

13 [(f)] **(g) Improvements, repairs or modifications necessary to make or keep the account holder's**
14 **primary dwelling habitable, accessible or visitable for the account holder or a household member.**
15 **This paragraph does not apply to improvements, repairs or modifications made to a rented primary**
16 **dwelling to achieve or maintain a habitable condition for which ORS 90.320 (1) places responsibility**
17 **on the landlord. As used in this paragraph, "accessible" and "visitable" have the meanings given**
18 **those terms in ORS 456.508.**

19 [(g)] **(h) The purchase of equipment, technology or specialized training required to become**
20 **competitive in obtaining or maintaining employment or to start or maintain a business, as specified**
21 **in the account holder's personal development plan for increasing the independence of the person.**

22 **(i) The purchase or repair of a vehicle, as specified in the account holder's personal de-**
23 **velopment plan for increasing the independence of the person.**

24 **(j) The saving of funds for retirement, as specified in the account holder's personal de-**
25 **velopment plan for increasing the independence of the person.**

26 **(k) The payment of debts owed for educational or medical purposes when the account**
27 **holder is saving for another allowable purpose, as specified in the account holder's personal**
28 **development plan for increasing the independence of the person.**

29 **(L) The creation or improvement of a credit score by obtaining a secured loan or a fi-**
30 **ancial product that is designed to improve credit, as specified in the account holder's per-**

27 of this section, all matching deposits in the account and all interest earned on matching deposits
28 shall revert to the fiduciary organization. The fiduciary organization shall use the reverted funds

28 [(5)] (6) If an account holder is removed from the program under subsection (2), (3) or [(4)] (5)
29 of this section, all matching deposits in the account and all interest earned on matching deposits
30 shall revert to the fiduciary organization. The fiduciary organization shall use the reverted funds
31 as a source of matching deposits for other accounts.

35 **SECTION 8.** ORS 315.271 is amended to read:

36 315.271. (1) A credit against taxes otherwise due under ORS chapter 316, 317 or 318 shall be
37 allowed for donations to a fiduciary organization for distribution to individual development accounts
38 established under ORS 458.685. The credit shall equal [*the lesser of \$75,000 or 75 percent of the*] **a**
39 **percentage of the taxpayer's donation amount, as determined by the fiduciary organization,**
40 **but not to exceed 70 percent of any donation amount.** To qualify for a credit under this section,
41 donations to a fiduciary organization must be made prior to January 1, [2016] **2022.**

42 (2) If a credit allowed under this section is claimed, the amount upon which the credit is based
43 that is allowed or allowable as a deduction from federal taxable income under section 170 of the
44 Internal Revenue Code shall be added to federal taxable income in determining Oregon taxable in-

4 (4) Any tax credit otherwise allowable under this section that is not used by the taxpayer in a
5 particular year may be carried forward and offset against the taxpayer's tax liability for the next
6 succeeding tax year. Any tax credit remaining unused in the next succeeding tax year may be car-
7 ried forward and used in the second succeeding tax year. Any tax credit not used in the second
8 succeeding tax year may be carried forward and used in the third succeeding tax year, but may not
9 be carried forward for any tax year thereafter.

3 device, the credit shall be based upon the first year energy yield of the alternative energy device
4 that qualifies under ORS 469B.100 to 469B.118. The amount of the credit shall be the same whether
5 for collective or noncollective investment.

6 (b) **Except as provided in paragraph (c) of this subsection**, the credit allowed under this
7 section for each category one alternative energy device for each dwelling may not exceed the lesser

 33 claiming a tax credit for construction or installation of an alternative energy device [*including a*
 34 *fueling station*] shall have the device certified by the State Department of Energy or constructed
 35 or installed by a contractor certified by the department under subsection [(5)] **(4)** of this section.
 36 [*This paragraph does not apply to an alternative fuel vehicle or to related equipment.*]

37 [(b) Certification of an alternative fuel vehicle or related equipment shall be accomplished under

39 [(4)] **(3)** Verification of the purchase, construction or installation of an alternative energy device
 40 shall be made in writing on a form provided by the Department of Revenue and, if applicable, shall
 41 contain:

42 (a) The location of the alternative energy device;

43 (b) A description of the type of device;

44 (c) If the device was constructed or installed by a contractor, evidence that the contractor has
 45 any license, bond, insurance and permit required to sell and construct or install the alternative en-

1 ergy device;

2 (d) If the device was constructed or installed by a contractor, a statement signed by the con-
3 tractor that the applicant has received:

4 (A) A statement of the reasonably expected energy savings of the device;

5 (B) A copy of consumer information published by the State Department of Energy;

6 (C) An operating manual for the alternative energy device; and

7 (D) A copy of the contractor's certification certificate or alternative energy device system cer-
8 tificate for the alternative energy device, as appropriate;

9 (e) If the device was not constructed or installed by a contractor, evidence that:

10 (A) The State Department of Energy has issued an alternative energy device system certificate
11 for the alternative energy device; and

12 (B) The taxpayer has obtained all building permits required for construction or installation of
13 the device;

14 (f) A statement, signed by both the taxpayer claiming the credit and the contractor if the device
15 was constructed or installed by a contractor, that the construction or installation meets all the re-
16 quirements of ORS 469B.100 to 469B.118 [*or, if the device is a fueling station and the taxpayer is the*
17 *contractor, a statement signed by the contractor that the construction or installation meets all of the*

1 installation of the same domestic water heating alternative energy devices authorized by the dealer

3 (e) If the State Department of Energy finds that an alternative energy device can meet the
4 standards adopted under ORS 469B.103, the Director of the State Department of Energy may issue
5 an alternative energy device system certificate to the taxpayer constructing or installing or having
6 an alternative energy device constructed or installed.

7 (f) An application for an alternative energy device system certificate shall be made in writing
8 on a form provided by the State Department of Energy and shall contain:

9 (A) A specific description of the alternative energy device, including, but not limited to, the

3 heating, the first year energy yield shall be based on the heating load of the swimming pool, spa or
4 hot tub as determined according to the procedure established by the department.
