

House Bill 2186

Sponsored by Representatives JOHNSON, KOMP (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Provides that core teaching standards apply to public charter schools.
Takes effect July 1, 2016.

A BILL FOR AN ACT

2 Relating to core teaching standards; amending ORS 338.025 and 338.115; and prescribing an effective
3 date.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 338.115 is amended to read:

6 338.115. (1) Statutes and rules that apply only to school district boards, school districts or other
7 public schools do not apply to public charter schools. However, the following laws do apply to public
8 charter schools:

9 (a) Federal law;

10 (b) ORS 30.260 to 30.300 (tort claims);

11 (c) ORS 192.410 to 192.505 (public records law);

12 (d) ORS 192.610 to 192.690 (public meetings law);

13 (e) ORS chapters 279A, 279B and 279C (Public Contracting Code);

14 (f) ORS 297.405 to 297.555 and 297.990 (Municipal Audit Law);

15 (g) ORS 326.565, 326.575 and 326.580 (student records);

16 (h) ORS 181.534, 326.603, 326.607, 342.223 and 342.232 (criminal records checks);

17 (i) ORS 329.045 (academic content standards and instruction);

18 (j) ORS 329.451 (high school diploma, modified diploma, extended diploma and alternative cer-
19 tificate);

- 11 (2) Notwithstanding subsection (1) of this section, a charter may specify that statutes and rules
- 12 that apply only to school district boards, school districts and other public schools may apply to a
- 13 public charter school.
- 14 (3) If a statute or rule applies to a public charter school, then the terms “school district” and
- 15 “public school” include public charter school as those terms are used in that statute or rule.
- 16 (4) A public charter school may not violate the Establishment Clause of the First Amendment
- 17 to the United States Constitution or section 5, Article I of the Oregon Constitution, or be religion
- 18 based.
- 19 (5)(a) A public charter school shall maintain an active enrollment of at least 25 students.
- 20 (b) For a public charter school that provides educational services under a cooperative agree-
- 21 ment described in ORS 338.080, the public charter school is in compliance with the requirements of
- 22 this subsection if the public charter school provides educational services under the cooperative
- 23 agreement to at least 25 students, without regard to the school districts in which the students are
- 24 residents.
- 25 (6) A public charter school may sue or be sued as a separate legal entity.
- 26 (7) The sponsor, members of the governing board of the sponsor acting in their official capacities
- 27 and employees of a sponsor acting in their official capacities are immune from civil liability with
- 28 respect to all activities related to a public charter school within the scope of their duties or em-
- 29 ployment.
- 30 (8) A public charter school may enter into contracts and may lease facilities and services from
- 31 a school district, education service district, public university listed in ORS 352.002, other govern-
- 32 mental unit or any person or legal entity.
- 33 (9) A public charter school may not levy taxes or issue bonds under which the public incurs li-
- 34 ability.
- 35 (10) A public charter school may receive and accept gifts, grants and donations from any source
- 36 for expenditure to carry out the lawful functions of the school.
- 37 (11) The school district in which the public charter school is located shall offer a high school
- 38 diploma, a modified diploma, an extended diploma or an alternative certificate to any public charter
- 39 school student who meets the district’s and state’s standards for a high school diploma, a modified
- 40 diploma, an extended diploma or an alternative certificate.
- 41 (12) A high school diploma, a modified diploma, an extended diploma or an alternative certificate
- 42 issued by a public charter school grants to the holder the same rights and privileges as a high
- 43 school diploma, a modified diploma, an extended diploma or an alternative certificate issued by a
- 44 nonchartered public school.
- 45 (13) Prior to beginning operation, the public charter school shall show proof of insurance to the

1 sponsor as specified in the charter.

2 (14) A public charter school may receive services from an education service district in the same
 3 manner as a nonchartered public school in the school district in which the public charter school is
 4 located.

5 **SECTION 2.** ORS 338.115, as amended by section 7, chapter 839, Oregon Laws 2007, and section

44 (2) Notwithstanding subsection (1) of this section, a charter may specify that statutes and rules
 45 that apply only to school district boards, school districts and other public schools may apply to a

1 public charter school.

2 (3) If a statute or rule applies to a public charter school, then the terms “school district” and
 3 “public school” include public charter school as those terms are used in that statute or rule.

4 (4) A public charter school may not violate the Establishment Clause of the First Amendment
 5 to the United States Constitution or section 5, Article I of the Oregon Constitution, or be religion
 6 based.

7 (5)(a) A public charter school shall maintain an active enrollment of at least 25 students.

8 (b) For a public charter school that provides educational services under a cooperative agree-
 9 ment described in ORS 338.080, the public charter school is in compliance with the requirements of
 10 this subsection if the public charter school provides educational services under the cooperative
 11 agreement to at least 25 students, without regard to the school districts in which the students are
 12 residents.

13 (6) A public charter school may sue or be sued as a separate legal entity.

14 (7) The sponsor, members of the governing board of the sponsor acting in their official capacities
 15 and employees of a sponsor acting in their official capacities are immune from civil liability with
 16 respect to all activities related to a public charter school within the scope of their duties or em-
 17 ployment.

18 (8) A public charter school may enter into contracts and may lease facilities and services from
 19 a school district, education service district, public university listed in ORS 352.002, other govern-
 20 mental unit or any person or legal entity.

21 (9) A public charter school may not levy taxes or issue bonds under which the public incurs li-
 22 ability.

23 (10) A public charter school may receive and accept gifts, grants and donations from any source
 24 for expenditure to carry out the lawful functions of the school.

25 (11) The school district in which the public charter school is located shall offer a high school
 26 diploma, a modified diploma, an extended diploma or an alternative certificate to any public charter
 27 school student who meets the district’s and state’s standards for a high school diploma, a modified
 28 diploma, an extended diploma or an alternative certificate.

29 (12) A high school diploma, a modified diploma, an extended diploma or an alternative certificate
 30 issued by a public charter school grants to the holder the same rights and privileges as a high
 31 school diploma, a modified diploma, an extended diploma or an alternative certificate issued by a
 32 nonchartered public school.

33 (13) Prior to beginning operation, the public charter school shall show proof of insurance to the
 34 sponsor as specified in the charter.

35 (14) A public charter school may receive services from an education service district in the same
 36 manner as a nonchartered public school in the school district in which the public charter school is
 37 located.

38 **SECTION 3.** ORS 338.025 is amended to read:

39 338.025. (1) The State Board of Education may adopt any rules necessary for the implementation
 40 of this chapter. The rules shall follow the intent of this chapter.

41 (2) Upon application by a public charter school, the State Board of Education may grant a
 42 waiver of any provision of this chapter if the waiver promotes the development of programs by
 43 providers, enhances the equitable access by underserved families to the public education of their
 44 choice, extends the equitable access to public support by all students or permits high quality pro-
 45 grams of unusual cost. The State Board of Education may not waive any appeal provision in this

1 chapter or any provision under ORS 338.115 (1)(a) to [(y)] (z), 338.120, 338.125 (4), 338.135 (2)(b) or
2 339.122.

3 **SECTION 4.** ORS 338.025, as amended by section 8, chapter 839, Oregon Laws 2007, and section
4 14, chapter 50, Oregon Laws 2008, is amended to read:

5 338.025. (1) The State Board of Education may adopt any rules necessary for the implementation
6 of this chapter. The rules shall follow the intent of this chapter.

7 (2) Upon application by a public charter school, the State Board of Education may grant a
8 waiver of any provision of this chapter if the waiver promotes the development of programs by
9 providers, enhances the equitable access by underserved families to the public education of their
10 choice, extends the equitable access to public support by all students or permits high quality pro-
11 grams of unusual cost. The State Board of Education may not waive any appeal provision in this
12 chapter or any provision under ORS 338.115 (1)(a) to [(z)] (aa), 338.120, 338.125 (4), 338.135 (2)(b) or
13 339.122.
