1 AN ACT Relating to ensuring the right of Washington residents to
2 possess legal firearms; and adding a new section to chapter 9.41 RCW.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** A new section is added to chapter 9.41 RCW
5 to read as follows:

6 All residents of the state who are legally entitled to possess
7 firearms under state and federal law have the right to possess the
8 following specifically identified firearms, as well as any other
9 firearm that is permitted to be possessed under federal law:
